

## **Joining Our Legacy Society**

Including Asheville Humane Society in your final giving plans allows you to enjoy the benefits of a gift to charity while making a powerful statement about your love of animals. Remembering AHS in your will, trust or other estate plans ensures our ability to help hundreds of thousands of animals through our lifesaving work.

Asheville Humane Society has a special way to thank legacy donors. The Legacy Society is our way of recognizing those whose planned gifts ensure a healthy financial future for the homeless pets in our care.

Legacy Society members have many ways to give to Asheville Humane Society (<u>please consult</u> your financial advisor and/or tax lawyer as is appropriate in your planning):

- Naming Asheville Humane Society as a beneficiary in a will or living trust. A will is a
  statement about what matters most in your life. By making a will you can ensure that your
  intentions are clearly expressed and will be followed by those administering your estate. A
  bequest costs you nothing now, yet provides a way for you to substantially support the
  mission of Asheville Humane Society in the future.
- Naming Asheville Humane Society as the beneficiary of a life insurance policy or retirement account. Making a beneficiary designation through your life insurance plan or retirement account is an easy and affordable way to support the life-saving work of Asheville Humane Society.
- **Real Estate Gifts.** Tax benefits for gifts of appreciated real estate are virtually identical to those for gifts or appreciated securities. Real property such as personal residences, undeveloped land, or farms may be transferred by deed with no liability for income or estate taxes on the appreciated value.
- Creating a charitable remainder trust (CRT). The CRT provides you with income for the term of the trust, a current tax deduction, and capital gains taxes are forgiven. Asheville Humane Society receives the remainder at the end of the trust term.

Benefits of membership include an invitation to our annual donor recognition event and eligibility to enroll your pets in our Peace of Mind Pet Care Program should you predecease them.
